With reference to the above subject, it is to inform that, in Tungabhadra Board 10 vacancies of Section Officers are lying vacant since long time against Karnataka quota. The matter of posting of staff was placed before the 217th meeting of Tungabhadra Board held on 29.09.2021. The Board noted the large number of vacancies of Section Officers against Karnataka and Andhra Pradesh quota and requested the Members of Andhra Pradesh and Karnataka to fill up the vacancies against their State quota as this will help in water management and Modernization works of TB Board Canals.

Further, it was requested Member, Karnataka in the Agenda Notes of 217th meeting to post SOs in Irrigation Branch as this will help in water management and Modernization works of Canals or otherwise think about the proposal of filling up of 50% vacancies from either of the participating Member States as suggested in 216th Board Meeting.

Both the Members have agreed to provide the Section Officers against their quota and subsequently, the Member, Andhra Pradesh has filled up the vacancies against AP quota, but, the posts against the Karnataka quota (10 Nos) are yet to be filled up by the Member, Karnataka

It is therefore requested to post the Section Officers against the Karnataka quota (10 Nos) in Tungabhadra Board immediately as promised in the Board meeting.

Further, in case if it is not possible to post Section officers (10 Nos) immediately, permission may kindly be communicated for filling up the 50% of vacancies from Andhra Pradesh for smooth water management and modernization works taken up by the Board till WRD, Karnataka fills up the posts.
